First preference to Graded Stake winners in past twelve (12) months. Second Preference to Graded Stake placed horses in past twelve (12) months. Third Preference to stakes winners in the past twelve (12) months. Fourth Preference starters with highest earnings in non-claiming races in 2019-20. Horses may be placed on the also eligible list.
