

## 18th Running Of THE HENRY S. CLARK STAKES \$100,000 Guaranteed

FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$100 each which should accompany the nomination, \$450 to pass the entry box. \$450 additional to start with \$100,000 Guaranteed (Grade I winners in the past twelve (12) months will have their entry and start fees waived if they start.), of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,000 each will be accepted by the usual time of entry with all other fees due as noted. Entry fee will be waived if horse starts. Weights: Three-Year-Olds, 120 lbs.; Older, 126 lbs. Non-winners of \$60,000 twice at one mile or over in 2018 allowed, 2 lbs.; \$60,000 once at one mile or over in 2018, 4 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). First Preference to Graded Stakes winners in past twelve (12) months. Second Preference to Graded Stakes placed horses in past twelve (12) months. Third Preference to stakes winners in the past twelve (12) months. Fourth Preference to starters with highest career earnings non-claiming races in 2018-19. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
