Non-winners of a graded stakes at one mile or over in 2018, allowed 3 lbs.; an open stakes at one mile or over in 2018, allowed 5 lbs.; any stakes at one mile or over in 2018, T lbs. Starters: Field shall be limited to fourteen (14) starters with preference to highest earnings in 2017-2018. Horses may be placed on the Also Eligible list. If the race does not have six (6) Maryland Million certified horses, the race will be opened up to the registered Maryland-breds (not Md-Sired) that were pre-entered. In races with six (6) or more Maryland Million certified at entry time, not including cross-entered horses, registered Maryland-breds (not Md-Sired) that were pre-entered may be entered and placed on the also eligible list. If a race scratches below six (6) horses, the Md-Breds on the also eligible list may draw in. Pre-entry Fee: \$375 due Wednesday, October 10, 2018 Entry Fee: \$1,125 due Wednesday, October 17, 2018 Starting Fee: \$1,500 due Saturday, October 20, 2018 Refunds: Pre-entry fee refundable to excluded horses Distribution of purses: First-55%; second-20%; third-10%; fourth-5%; fifth-3%. In fields with nine or less starters, sixth through last will divide 9% evenly.
