A HANDICAP FOR THREE-YEAR-OLDS AND UPWARD Weights: Tuesday, October 16, 2018 Starters: Field shall be limited to fourteen (14) starters with preference to high weights on the scale. Horses may be placed on the Also Eligible list. If the race does not have six (6) Maryland Million certified horses at entry time, not including cross-entered horses, the race will be opened up to the registered Maryland-breds (not Md-Sired) that were pre-entered in races with six (6) or more Maryland Million certified at entry time, not including cross-entered horses, the face of the also eligible list may draw in. Pre-entry Fee: \$250 due Wednesday, October 10, 2018 Entry Fee: \$750 due Wednesday, October 17, 2018 Starting Fee: \$1,000 due Saturday, October 20, 2018 Refunds: Pre-entry fee refundable to excluded horses Distribution of purses: First-55%; second-20%; third-10%; fourth-5%; fifth-3%. In fields with nine or less starters, sixth through last-2%; any monies not distributed shall be divided pro-rata among the first five finishers. In fields with 10 or more starters, sixth through last will divide 9% evenly.
