FOR THREE-YEAR-OLDS AND UPWARD Weights: Three-Year-Olds-121 lbs., Older-126 lbs. Non-winners of a graded stakes in 2018, allowed 3 lbs.; an open stakes in 2018, allowed 5 lbs.; any stakes in 2018, 7 lbs. Starters: Field shall be limited to fourteen (14) starters with preference to highest earnings in 2017-2018. Horses may be placed on the Also Eligible list. If the race does not have six (6) Maryland Million certified horses at entry time, not including cross-entered horses, the race will be opened up to the registered Maryland-breds (not Md-Sired) that were pre-entered. In races with six (6) or more Maryland Million certified at entry time, not including cross-entered horses, registered Maryland-breds (not Md-Sired) that were pre-entered may be entered and placed on the also eligible list. If a race scratches below six (6) horses, the Md-Breds on the also eligible list may draw in. Pre-entry Fee: \$313 due Wednesday, October 10, 2018 Entry Fee: \$937 due Wednesday, October 17, 2018 Starting Fee: \$1,250 due Saturday, October 20, 2018 Refunds: Pre-entry fee refundable to excluded horses Distribution of purses: First-55%; second-20%; third-10%; fourth-5%; fifth-3%. In fields with nine or less starters, sixth through last-2%; any monies not distributed shall be divided pro-rata among the first five finishers. In fields with 10 or more starters, sixth through last will divide 9% evenly.
