FOR THREE YEAR OLDS AND UPWARD \$100 nomination fee. \$400 to pass the entry box, \$400 additional to start, with \$100,000 Guaranteed, (Grade I winners in past twelve (12) months will have their entry and start fees waived if they start) of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,000 each will be accepted by the usual time of entry and all other fees due as noted. Entry fee will be waived if horse starts. Weight: Three Year Olds, 120: Older 126; Non-winners of \$60,000 twice in 2018-19, allowed 2 lbs.; \$60,000 once in 2018-19, 4 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). First Preference to Graded Stake winners in past twelve (12) months. Second Preference to Graded Stake placed horses in past twelve (12) months. Third Preference to starters with highest earnings in 2018-19. Horses may be placed on the also eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
