

## THE PRIVATE TERMS STAKES

\$100,000 Guaranteed

FOR THREE-YEAR-OLDS By free subscription. \$500 to pass the entry box, \$500 additional to start, with \$100,000 Guaranteed (Grade I winners in the past twelve (12) months will have their entry and start fees waived if they start.), of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,000 each will be accepted by the usual time of entry with all other fees due as noted. Entry fee will be waived if horse starts. Weight 122 lbs. Non-winners of a Sweepstakes at one mile or over, allowed 2 lbs.; \$50,000 at a mile or over allowed, 4 lbs. (Maiden, Claiming and starter races not considered in estimating allowances). First preference to Graded Stake winners in past twelve (12) months. Second Preference to Graded Stake placed horses in past twelve (12) months. Third Preference to starters with highest earnings in 2018-19. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
