


## BACKSTRETCH WINTER NOTIFICATIONS:

All faucets need to be shut off after each use. All hoses must be disconnected from faucets to prevent freezing or broken pipes. All hoses in wash stall barn must be disconnected after workday is complete. Each faucet handle must be turned off or in closed position in wash stall and all barns. Please make sure all doors to bathrooms, boiler rooms or any rooms that water lines are in are closed.

ATTENTION HORSEMEN: The use of rubber bands on any part of a horse's body during training or racing at an MJC facility is prohibited. Rubber bands may be used for braiding manes or tails.

LAUREL TRAINING HOURS (track closes to horses entering track at time stated):
Non-race days: 5:30-6:55, break(7:00-7:30), 7:30-8:55, break (9:00-9:30), 9:30-10:30
Race days: 5:30-6:55, break(7:00-7:30), 7:30-8:55, break (9:00-9:30), 9:30-10:00
SATURDAY AND SUNDAY: First 10 minutes upon track re-opening after first break are for workers ONLY

It is against HISA rules to breeze a horse within 7-days of an intra-articular injection. If you inject a horse on Saturday, you cannot breeze the horse until the following Saturday.

MJC will no longer be accepting blood drawn slips for coggins. The coggins MUST come back negative and turned into Horse ID. Must be within 365 days of the date the blood was drawn.

Horses shipping in to race, that are NOT on Lasix MUST be on the grounds no later than two (2) hours prior to the post time of your race if you are in an early race OR by 11:00 am if you are in a later race.

TRAINERS: YOU MUST HANG YOUR "IN TODAY" SIGNS ON YOUR HORSE'S STALL DOOR ON RACE DAY. FAILURE TO DO SO MAY RESULT IN A SCRATCH AND FINE!

Horses coming to the paddock with lip chains MUST have them covered! Horses paddock schooling must also have covered lip chains.

1ST TIME GELDINGS: Private vets MUST notify the horse identifier when a horse is gelded. Michele Enck- ext. 5473. michele.enck@marylandracing.com. Trainers MUST state 1st time gelding when making an entry.
