ATTENTION HORSEMEN. ALL HORSES SHIPPING IN TO RUN MUST GO TO THE RECEIVING BARN.

Please be reminded that mask use is mandatory in stable areas and the starting gate to. All riders and trainers gate schooling MUST have a mask on or they will be turned away. This mask policy will be strictly enforced. Access privileges may be suspended for repeat offenders.

ATTENTION HORSEMEN: You MUST declare bar shoes at time of entry.

REMINDER: With herpes season right around the corner, please ensure all vaccinations are up to date and are turned in to the Racing Office.

NO DRIVING ON THE HORSE PATHS!!!!

EFFECTIVE IMMEDIATELY: All TSG tracks are no longer accepting horses over 10 years of age into races.

ATTENTION HORSEMEN: Every claimed horse not subjected to testing will now be sent to the "CLAIM ONLY BARN" located next to the detention barn for observation by the state veterinarian for a period up to one hour. Claimed horses will no longer be picked up in the paddock. The original groom will be required to bring the claimed horse to that barn and stay with them until released. Claimed horses will be observed cooling out and required to jog for the state veterinarian. The horse will then either be cleared to leave with the new owner's groom or the claim will be voided.

STAKES BOOK CORRECTION:

The Frank Y. Whiteley is for Three Year Old and Upward.

ATTENTION HORSEMEN: Due to necessary turf maintenance and the turf lanes that we will be able to use in April, the distances for the DAHLIA and HENRY CLARK to be run on April 17th will need to be changed to ONE MILE AND ONE SIXTEENTH ON THE TURF.

EFFECTIVE MARCH 1:

Clenbuterol will not have a permissive threshold. The presence of the substance in a blood or urine sample at any detectable level will constitute a violation.

A horse found with clenbuterol in its system will be disqualified and the trainer subject to disciplinary action.

The Racing Medication and Testing Consortium has recommended that clenbuterol not be administered to a horse within 28 days of a race at a minimum.

Because clenbuterol is recognized as a therapeutic medication, the regulation allows for its use if the following conditions are met:

- a. The prescription for clenbuterol is made for a specific horse based upon a specific diagnosis. The prescription and volume dispensed cannot exceed a treatment period of 30 days.
 - b. The veterinarian must provide a copy of the prescription and diagnosis to the Equine Medical Director for review and approval. The horse may not receive clenbuterol before this approval is issued.
 - c. Trainers must make daily notification to the official veterinarian of horse(s) in their custody having been administered clenbuterol. Notification shall be made on a form and by a deadline designated by the Maryland Racing Commission.
 - d. A horse administered clenbuterol shall be placed on the official veterinarian's list. The horse must meet all conditions for removal from the list including a timed workout and blood and urine sampling. Both samples must have no detectable clenbuterol.
 - e. A horse may not enter to race until it has completed all the requirements in subdivision (d).
2. If a clenbuterol is detected in a horse's post-race or out-of-competition sample and appropriate notification as outlined in subdivision 1(a) or (b) was not completed, the horse

shall immediately be placed on the official veterinarian's list pending the outcome of an investigation. The horse shall be required to meet all conditions for removal from the veterinarian's list outlined in subdivision 1(d), above.
