**Footnotes**

SONNY INSPIRED circled the turn four deep, advanced outside GURSKY to take the lead inside the eighth pole and drove clear. ANY COURT INASTORM lacked speed, was two wide around the turn, swung to the five path in upper stretch and rallied outside horses. GURSKY prompted the pace three deep around the turn, gained the lead in upper stretch and faded late inside the top pair. FINAL PROSPECT saved ground on the turn, eased out for the drive, raced in the two path inside horses in the stretch and failed to menace. ARROGANT OFFICER, along the rail on the turn, eased out in upper stretch and passed tired foes late. D C DANCER sprinted to the early lead, set the pace along the rail and weakened in mid stretch. JACK'S IN THE DECK prompted the pace in the two path, gave way and drifted out in upper stretch.
