

ROSE BRIER broke sharply then was angled in after clearing, set a rated pace inside, shook clear of PHLASH PHELPS when set down soon into the lane, kept on under vigorous handling and held firm. GOLDEN SABRE, four wide early while settled off the pace, edged up between foes into the far turn, dropped to the inside while advancing past the five sixteenths, appeared to momentarily want to be angled out leaving the eighth pole, shifted back in and kept on gamely to overtake PHLASH PHELPS for the place. PHLASH PHELPS prompted the pace outside the winner, couldn't quite quicken with that one past the three sixteenths but kept on valiantly to the wire. EDGE OF REALITY was lightly steadied entering the backstretch, angled in and moved up to stalk the pace, came off the inside in upper stretch, chased past the furlong grounds but failed to generate the needed response. SPECIAL ENVOY stalked the leaders while removed from the inside, was under a ride pursuing into the lane, steadled off the heels of EDGE OF REALITY when that one angled out in upper stretch then failed to recover. CALL FIRST was checked when in tight quarters nearing the first turn, recovered to rate off the pace, entered the lane three wide and lacked a bid. DYNAMIC STRIKE, wide off the pace, was under a solid ride leaving the far turn, circled five wide into the lane but could not generate a rally. CAGE FIGHTER steadied along the rail around the first turn, bobbled significantly soon into the backstretch, bobbled again nearing the far turn, was pulled up nearing the five sixteenths, had his rider dismount in upper stretch and walked off on his own courage. It was reported by the state veterinarian that he encountered problems with both front shoes. An objection by the rider of SPECIAL ENVOY against EDGE OF REALITY for alleged interference in the stretch was not allowed
