

## Footnotes

IN THE NAVY NOW broke outward and bumped with REDMOOR, corrected and settled within range while saving ground, crept closer leaving the far turn, slipped through along the rail after ALTO BELLE drifted off of it entering the lane, spurted clear in mid stretch, drifted out when roused left handed, was briefly straightened, came out again in deep stretch while continuing under left handed rousing, herded out A P MAJETSTIC then held firm. A P MAJETSTIC , three to four wide stalking the pace, progressed under a strong ride into the lane, ranged up outside IN THE NAVY NOW leaving the sixteenth marker then was forced to steady when bothered nearing the wire. ITS A JOURNEY prompted the pace two to three wide, took a short lead entering the lane, could not quicken with IN THE NAVY NOW leaving the three sixteenths, gave hard pursuit behind rivals nearing the sixteenth pole then gave way grudgingly. ALTO BELLE cleared early and set the pace towards the rail, was kept straight with a firm left grip, handled outside pressure leaving the far turn, wandered off the rail entering the lane and surrendered. INCLUDE A CHECK , off the rail while within striking distance, failed to kick on when roused and gave way after six furlongs. REDMOOR , bumped at the break, regrouped to raced forwardly two wide, had no response leaving the far turn and faltered. Following a stewards' inquiry and objection by the rider of A P MAJETSTIC, IN THE NAVY NOW was disqualified from first and placed second for causing interference nearing the wire.
