JOY settled in the clear while off the inside, gathered momentum four wide leaving the three eighths pole, moved out a bit wider entering the lane, closed under left handed rousing to join VIELSALM in mid stretch, dueled outside that one from there and narrowly proved best. VIELSALM rated in range three wide, crept closer nearing the quarter pole, responded when roused in upper stretch, moved four wide to a short lead approaching the eighth pole, dueled inside the winner and just missed in a sharp effort. GREEN WAVE GIRL settled off the pace, came three wide under a ride into the lane, angled out and finished willingly to just get the show. LUCY BOO rated off the pace while saving ground, edged closer nearing the stretch, shifted out near the eighth pole and kept trying between rivals. DEBBIE'S TUDE prompted the pace two to three wide, bid to engage the leader in upper stretch, dueled past the eighth pole then faded late. LIONHEARTED LADY cleared early and set a slow pace towards the rail, met a bid from DEBBIE'S TUNE entering the stretch, dueled, kept on willingly to deep stretch then weakened. COMPLETE ST. lagged off the rail, was under pressure into the lane but could not drum up a response. NORTHERN SMILE saved ground, was under pressure leaving the far turn and came up empty. PAGAN PRIESTESS was outrun.
