Third Preference to stakes winners in the past twelve (12) months. Fourth Preference to starters with highest career earnings non-claiming races in 2019-20. Horses may be placed on the also eligible list. All Black-Eyed Susan starters and also eligible horses must be stabled at Pimlico Race Course by Wednesday, September 30, 2020.
