Supplemental nominations of \$1,500 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three-Year-Olds, 121 lbs.; Older, 125 lbs. Non-winners of \$70,000 twice at one mile or over in 2019-20, allowed 2 lbs.; \$70,000 once at one mile or over in 2019-20, 4 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). First Preference to Graded Stakes winners in past twelve (12) months. Second Preference to Graded Stakes placed horses in past twelve (12) months. Third Preference to stakes winners in the past twelve (12) months. Fourth Preference to starters with highest career earnings non-claiming races in 2019-20. Horses may be placed on the also eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
