A HANDICAP FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD Weights: Tuesday, October 20, 2020 Starters: Field shall be limited to fourteen (14) starters with preference to high weights on the scale. Horses may be placed on the Also Eligible list. A race with less than eight (8) Maryland Million-eligible entries will open up to registered Maryland-Breds, for the sole purpose of maintaining a field size eight (8). The registered Maryland-Breds will draw in off the also-eligible list based on the following preferences: 1. Total earnings based on race specific surface (Turf/Dirt) since October 20, 2019: 2. Total earnings since October 20, 2019. Pre-entry Fee: \$250 due Wednesday, October 14, 2020 Entry Fee: \$750 due Wednesday, October 21, 2020 Starting Fee: \$1,000 due Saturday, October 24, 2020 Refunds: Pre-entry fee refundable to excluded horses. Distribution of purses: First-55%; second-20%; third-10%; fourth-5%; fifth-3%. In fields with nine or less starters, sixth through last-2%; any monies not distributed shall be divided pro-rata among the first five finishers. In fields with 10 or more starters, sixth through last will divide 9% evenly.
