First preference to Graded Stake winners in past twelve (12) months. Second Preference to Graded Stake placed horses in past twelve (12) months. Third Preference to stakes winners in past twelve (12) months. Fourth Preference to starters with highest earnings in non-claiming races in 2019-2020. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
