Second Preference to Graded Stake placed horses. Third Preference to stakes winners. Fourth Preference to starters with highest earnings in non-claiming races. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
