FOR THREE-YEAR-OLDS By free subscription. \$500 to pass the entry box. \$500 additional to start with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,000 each will be accepted by the usual time of entry with all other fees due as noted. Entry fee will be waived if horse starts. Weight: 124 lbs. Non-winners of a Sweepstakes at one mile or over, allowed 2 lbs.; \$50,000 at one mile or over in 2020, 4 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). First Preference to Graded Stakes winners in past twelve (12) months. Second Preference to Graded Stakes placed horses in past twelve (12) months. Third Preference to stakes winners in the past twelve (12) months. Fourth Preference to starters with highest career earnings non-claiming races in 2019-20. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner. The winning horse will automatically be given an entrance into the Preakness. The horse must be nominated to the Triple Crown to be eligible.
