



THE THIRTY EIGHT GO GO STAKES \$100,000 Guaranteed

FOR FILLIES AND MARES THREE-YEAR-OLDS AND UPWARD By free subscription. \$500 to pass the entry box. \$500 additional to start with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,000 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three-Year-Olds, 123 lbs.; Older, 125 lbs. Non-winners of \$60,000 twice at one mile or over in 2020 allowed, 2 lbs.; \$60,000 once at one mile or over in 2020, 4 lbs. (Maiden and claiming races not considered in estimating allowances). First preference to Graded Stake winners in past twelve (12) months. Second Preference to Graded Stake placed horses in past twelve (12) months. Third Preference to stakes winners in past twelve (12) months. Fourth Preference to starters with highest earnings in non-claiming races in 2019-2020. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
