Turf Works Sunday weather permitting 9:30 - 10:30am. Working on the turf will require a \$150 fee which must be paid for before a turf workout. All turf sign ups must be submitted to the racing office by Noon Saturday before turf works on Sunday. Sign-ups are a first-come, first-serve basis and a maximum of 20 horses will be allowed to work on the turf.

ATTENTION HORSEMEN. ALL HORSES SHIPPING IN TO RUN MUST GO TO THE RECEIVING BARN NO EXCEPTIONS.

"As addressed in the Maryland Racing Commission's letter dated April 10, 2020, the Breeder and Stallion bonuses will be evaluated and paid once Maryland Bred Race Fund's revenue streams are studied and the Maryland Racing Commission approves percentages and a payment plan. The approved plan will require that the percentages and timing be based on the funds available. This policy went into effect with the return of live racing on May 30, 2020."

TRAINERS responsibility to contact the clockers to make sure works are posted.

If a horse is sold or transferred, The health records on the horse MUST go to the stewards with the transfer slip.

The use of hog rings or similar devices placed around the maxillary incisors to prevent cribbing in horses are strictly prohibited at all MJC properties. These devices are detrimental to the welfare of the horse due to the potential to cause persistent pain, damage to the gingiva, periodontal disease and abrasive wear to adjacent teeth.

Attn Trainers: This is a reminder that if you have a horse entered MTO, if you want to have your horse treated in the event that you think the race may come off of the turf, you must contact Melanie Martin, lasix clerk at 443-631-4891 early in the morning. Don't wait until treatment time for that race.

Reminder: Maryland Racing Commission licenses for all stable employees at Laurel Park and Pimlico MUST be renewed by June 30, 2020.

Please be reminded that mask use is mandatory in stable areas and the starting gate to avoid a shutdown caused by an outbreak amongst our population. All riders and trainers gate schooling MUST have a mask on or they will be turned away. This mask policy will be strictly enforced. Access privileges may be suspended for repeat offenders.

ATTENTION HORSEMEN: Beginning August 1st, ALL 150 day layoff forms MUST be submitted AND approved PRIOR to entry. Please allow 2-3 weeks for approval from the Equine Medical Director.
