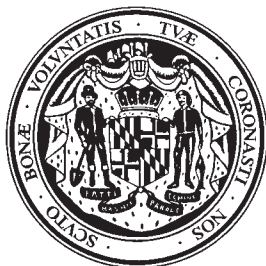

Big Events Procedures

HOUSE RULES

1. SCOPE

The following races are considered Big Events at MJC:

1. Barbara Fritchie Stakes
2. The General George Stakes
3. Black Eyed Susan
4. Preakness Stakes
5. Maryland Millions Classic
6. Breeders' Cup Races at MJC property
7. Breeders' Cup Future Stars Friday Races at MJC property

The days these races are held are considered Big Event Days. The above list is subject to change and the Racing Office will update the condition book accordingly.

2. PROCEDURES

There are two groups of horses on Big Event days. The first group is those horses that are racing in the Big Events (Big Event Horses). The second group are those horses racing in the undercard stake races that day (Undercard Stakes Horses). Each set of horses will be subjected to increased scrutiny and specific procedures.

The procedures for Big Event Horses are as follows:

1. All horses nominated to a Big Event are subject to Out of Competition Testing (OOCT). OOCT tests will be taken within the month of the Big Event and consist of blood, urine, and/or hair testing.
2. Trainers for Big Event Horses must provide the Equine Medical Director 14-days' worth of veterinary records 72 hours prior to the race. Daily veterinary records between 72 hours and the race must be provided to the Equine Medical Director. These records can be submitted to the MRC office or sent electronically to: Elizabeth.daniel@maryland.gov.
3. Big Event Horses must be on the grounds of the racetrack at which the event will occur a minimum of 72 hours prior to the Big Event. Horses may not stable at training facilities or other regulated facilities during this time – only at the Big Event location.
4. The Racing Office will provide Big Event Horses specific saddle towels that are numbered or include the horse's name to allow for identification of the horse during training. Towels will be provided to trainers or their designee on the day horses are required to arrive on the track.



HOUSE RULES

Big Events Procedures Cont'd

5. Big Event Horses must wear their designated saddle towel each day for training up to and including race day. The saddle towel number must not be obscured by other equipment and shall be visible to the Veterinary Team.
6. The Veterinary Team will inspect horses daily beginning the morning after the designated arrival time and continuing through and including race day. Horses should not be put in ice or bandages prior to the daily examination.

The procedures for Undercard Stakes Horses is as follows:

1. All Undercard Stakes Horses are subject to Out of Competition Testing (OOCT) consistent with local regulations.
2. Undercard Stakes Horses must be at a racing or training facility monitored by the Veterinary Team during training a minimum of 72 hours prior to post time for their scheduled race – this may include certain non-TSG facilities as determined by the Racing Office and CVO.
3. The Racing Office will provide Undercard Stakes Horses specific saddle towels that are numbered or include the horse's name to allow for identification of the horse during training. Towels will be provided to trainers or their designee on the day horses are required to arrive on the track or at the training facility.
4. Undercard Stakes Horses must wear their designated saddle towel each day for training up to and including race day. The saddle towel number must not be obscured by other equipment and visible to the Veterinary Team.
5. Undercard Stakes Horses will be monitored by the Veterinary Team during training.
6. The Veterinary Team shall examine horses on race day. Additional examinations may be conducted on the days preceding race day.

Graded Stakes, Two Year Olds, and Furosemide:

Beginning in 2020, all Two Year Olds that race at MJC properties are prohibited from receiving furosemide within 48 hours of post time. Beginning in 2021, all horses entered in Graded Stakes races at MJC properties are prohibited from receiving furosemide within 48 hours of post time.

Administration of furosemide at 48 hours or more may be done by the trainer's private veterinarian.

To Our Valued Owners, Trainers and Connections,

At **1/ST RACING**, one of our top priorities is to protect the welfare and safety of horses that train and race at our venues. We believe this duty of care extends to horses during their racing careers and beyond, as they leave our facilities to race and train elsewhere or to retire.

As part of **1/ST RACING's** ongoing and steadfast commitment to achieving the highest standard of horse care and safety in Thoroughbred racing, we reviewed the shipment of horses via cargo ship to race and train in other parts of the world. In consultation with our Chief Veterinary Officer, Dr. Dionne Benson, we have determined that the conditions in which these horses are transported via cargo ship are inappropriate, inhumane and represent a significant risk to their health and welfare.

Accordingly, effective immediately, any trainer or owner who is associated with shipping horses via cargo ship will no longer be welcome at any of our training or racing facilities. Trainers and owners shipping horses are responsible for performing the required due diligence to ensure horses in their care are transported in safety by humane methods. Failure to prevent the shipping of horses via cargo ship will result in the immediate removal of the associated owner or trainer's horses from any, and all, **1/ST RACING** venues.

I have communicated with the horsemen's groups in each of our jurisdictions in California, Florida and Maryland and have received their full support on this issue. HISA OPERATIONS BULLETIN

November 11th, 2022

Required Vaccines and Tests

The January 1, 2023, deadline to have all your required vaccines and tests recorded on the HISA portal is fast approaching. On this date, HISA will start enforcing this regulation, preventing your horse from racing if these vaccines and tests are A) not listed on the Horse's Health records or B) not up to date, as required by HISA rule 2143.

The Required Tests and Vaccines:

- Certificate of Veterinary Inspection
- Coggins Test
- Encephalitides Vaccine
- Rabies Vaccine
- Tetanus Vaccine
- Influenza Vaccine
- Rhinopneumonitis Vaccine

Exception

If a health certificate is submitted for a horse at a licensed racetrack facility or training center and is then transported directly to another licensed facility within the same state, another health certificate is not required to be provided. However, if the horse is transported from a licensed racetrack or training center to an unlicensed facility or farm between races or leaves the state between races, the health certificate must be presented.

Regulations for Each Test and Vaccine

HISA Rule 2143 establishes the requirements for each test and vaccine. In order to race, these requirements must be met. To ensure your horse can race, make sure your horse's negative Coggins test and necessary vaccines are up to date, as required by HISA Rule 2143.

15% Developer Bonus

The Maryland Thoroughbred Horsemen's Association and Maryland Jockey Club have announced changes to the Maryland-Bred Owner Bonus Program to accommodate a new Developer Bonus Program, beginning in phases with the Jan. 22 racing program at Laurel Park.

A 15% bonus will be paid to the developer—the owner or owners of a horse when it makes its first career start—for any Maryland-bred that finishes first, second or third in an open overnight race at a Maryland track. The Developer Bonus only applies to a horse still owned continuously by the original owner of the horse as of Jan. 22, 2021, or the owner of a horse that makes its first career start after January 22, 2021.

The Developer Bonus is not part of the purse and will not be included in a horse's earnings. The bonuses will be paid monthly once the testing of samples is completed and the races are released by the stewards. It will be the responsibility of the developer to provide the Horsemen's Bookkeeper with a W-9 if they do not already have a horsemen's account.

A 15% Maryland-Bred Owner Bonus will continue to be paid to all Maryland-bred horses that finish first, second or third in an open overnight race in Maryland and will continue to be part of the purse.

It is designed to provide additional incentives for owners to support the Maryland racing program through the development of weanlings, yearlings and 2-year-olds, thus increasing the number of horses available to fill races.

150-Day Layoff Report Laurel, Pimlico, Timonium

Trainers must complete a form for any horse that has not raced for 150 days or more. The form will be submitted, prior to entry, to Equine Medical Director Dr. Elizabeth Daniel at elizabeth.daniel@Maryland.gov. The form must be completed and submitted a minimum of 30 days* before entry and is valid for 60 days from the date of submission. This does not apply to first-time starters.

*This requirement may be waived by Dr. Daniel. You can find the form on the MTHA website.

TRPB DIGITAL TATTOOS

2022 Update – Laurel and Pimlico

In effect since January 2020, a Thoroughbred making its first lifetime start requires a TRPB Digital Tattoo.

Sign up for Tattooing at the Laurel or Pimlico Horse ID office or Racing Office. List the horse's name, barn number, your name and cell phone number. You need to sign up any horse that is ready for their gate card and is planning to make their first lifetime start at Laurel and/or the Pimlico Meet.

All foals of 2017 thru 2020 have microchip numbers on The Jockey Club foal registration papers which the TRPB Technician will validate prior to confirming the markings & documenting through digital photos. Some older horses may also have a microchip listed on their papers.

The TRPB Technician will scan the microchip to access the digital copy of the foal certificate, validate the information, verify the markings, color & gender, and take 10 -14 photos of the horse to digitally document all equine attributes.

Bandages, poultice, blankets must be off the horse and the horse must be named by the time the TRPB Technician is present to digitally tattoo each horse. For foals of 2017 and older, the Registration Papers must accompany the horse. Foals of 2018 on have electronic certificates.

The fee is \$90.00 for the Digital Tattoo and MUST be paid prior to the TRPB Tattoo Technician doing the work. A voucher may be obtained from the Horsemen's Bookkeeper in advance, otherwise, you can pay with a credit card, Apple Pay, Google Pay, check or cash.

HOUSE RULES

ELIGIBILITY RULE STALLS WILL NOT BE ASSIGNED AND ENTRIES WILL NOT BE ACCEPTED FOR ANY HORSE WHICH:

1. Has started for a claiming price of less than \$5,000 unless having finished first, second, or third for a claiming price of \$5,000 or more since starting for less than \$5,000.
2. Has not finished first, second, third, or fourth in its last eight starts.
3. Is a maiden which has started for a claiming price of less than \$5,000.
4. Has not won a race for a claiming price of \$5,000 or more or a non-claiming race since starting for a maiden claiming price of less than \$5,000.

Starter and Optional claiming races will be considered non-claiming races in determining eligibility under this rule.

Horses which become ineligible under this rule shall forfeit stall space assigned to them.

DORMITORIES AND STABLES

Living quarters must be kept clean. Small radios may be plugged in outlets; otherwise light fixtures are not to be used for anything except lighting.

No oil, or electric heaters or cooking units are permitted.

As to the punitive powers of the Stewards see rule No. 09.10.03.02.

Electric wiring is not to be altered by additional plugs or wire.

Light bulbs of more than 100 watts are not allowed.

Sanitary equipment is not to be misused; the wash basins must not be used for washing clothes or equipment.

Smoking. Smoking in the shed rows and stalls is strictly forbidden. Manure must be placed in the manure pits at all times.

Horsemen. Horsemen must conduct themselves in a sober and respectable manner at all times.

Hay and Straw. Hay and straw should be stored in limited quantities, shall be kept baled at all

times except when in actual use and shall be stored only in such areas as have been approved by the Association.

Fences. The designated entrances must be used; fences are not to be damaged in order to get in or out of the grounds. Entering the grounds without authorization is trespassing and violators will be prosecuted.

Dogs. Dogs will not be allowed on the grounds at any time.

Automobiles. Autos must not be stored under stable sheds at any time. No carts may be parked within 20 feet of fire hydrants. Drivers must strictly observe the posted speed limits. (All cars must display parking stickers.)

Visitors. No visitors are allowed in the stable area at any time unless authorized.

Registered Personnel. Trainers shipping in from out-of-town for any race must have all personnel accompanying the horse registered immediately.

Employee Conduct. Trainers will be held responsible for the conduct of their employees while on the grounds of the Association.



HOUSE RULES

ENTRIES

Horses penalized in a race shall not be entitled to any of the allowances in such race.

Horses not entitled to the first allowance in a race shall not be entitled to the second, and if not to the second, then to no subsequent allowance.

Winner or Non-winner of a stated sum means winner or non-winner of a single race of that value to the first horse.

Horses not engaged as starters will not be permitted to exercise on the track between races unless permission is received from the stewards.

Any owner or trainer making an entry in a race for which his or her horse is not eligible is subject to fine by the stewards.

It is the responsibility of the person who enters a horse to provide the Racing Secretary with bleeder medication status of the horse on the entry blank and also provide the veterinary office with a "bleeder" certificate if racing from out of state.

OPTIONAL CLAIMING RACES

A winner of an Optional Claiming Race if entered not to be claimed shall be considered a winner of an allowance race.

A winner of an Optional Claiming Race if entered to be claimed shall be considered a winner of a claiming race.

When stalls have been allocated they are for the horses of the person to whom assigned. No owner or trainer shall be permitted to share stalls without permission. Any violation of this regulation may result in the offending person being asked to remove his horses from the grounds. Since stall space is at a premium, it is understood that stall space not used in allotment reverts to the Association.

LAUREL/PIMLICO TURF RACE CANCELLATION

If a turf race is cancelled due to weather, track condition, or a decision of the stewards, that same race will be run on the main track distance remaining the same.

LAUREL EXCEPTION:

1 & 1 /16 mile turf races shall be transferred to 1 mile on the main track.

PIMLICO EXCEPTION:

1 mile turf races shall be transferred to 1 & 1 /16 mile on the main track.

1 & 1/2 mile turf races shall be transferred to 1 & 1/4 mile on the main track.

TURF RULES

In All Maiden Special Weight Turf Races, Preference Will be Given To Horses Which Have Not Started For Less Than \$20,000 In Their Last Three Starts. Winners Are Preferred In All Winner's Turf Races

SHOE RULE

A horse may not be permitted to start if it has shoes on the::

DIRT: Front hooves are permitted 2 millimeters or less full rims (no raised toes); Hind hooves are permitted 4 millimeters or less full rims or toe grabs up to 4 millimeters in height. TURF: Traction devices are prohibited on both front and hind hooves. Traction devices include but are not limited to rims, toe grabs, bends, jar caulks, and stickers.

SCRATCH RULES

- Parts Of Entry Scratches Will **Not** Be Processed Until 11:00 AM The Day Of The Race if **Neither** Part Of The Entry Runs Then A **Veterinarian Excuse** Will Be Required For Both Horses.
- A Horse May Be Excused From A Race After Scratch Time Provided that: - A Medical Reason Is Given Accompanied By

A Vet Certificate.

- Any Horse Scratched Off The Program for **Track Condition** can not be run out of town for 10 days.
- Penalty Days Will Be Counted On A Calendar Day Basis From The Day The Horse Is Scratched, If The Scratch Is Submitted At, Or Prior To, Scratch Time; OR From The Day The Horse Was Scheduled To Race If The Scratch Is Submitted At A Later Time And The Horse Cannot Be Taken Off The Program.
- Any Unexcused Scratch By A Trainer Will Result In A \$500 Fine By The Stewards!
- Trainers Must Have The Lasix Certificate Form Turned In To The State Veterinarian Before The Horse Can Be Entered On Lasix. The Form Must Be Signed By A Vet Licensed By the Maryland Racing Commission.

SPECIAL NOTICES

- Horse's entered Main Track Only are **EXPECTED** to run when the race comes off the turf.
- Any Main Track Only not running shall be subject to the same scratch rules and penalties for scratching as any other race. (Veterinarian Scratch.)
- The Stronach Group has formally adopted a company-wide policy promoting the humane treatment of racehorses, the company announced Oct. 10. Under the policy, any trainer or owner stabling at an MJC facility who directly or indirectly participates in the transport of a horse from an MJC facility to either a slaughterhouse or an auction house engaged in selling horses for slaughter will be prohibited from having stalls at any MJC facility. The policy also applies to any actions related to the transport of a horse from an MJC facility where the ultimate intended result is a horse's slaughter.
- **New Stewards Policy:** 10lb. apprentice can not ride turf races and
For the first (5) five career mounts;
can not ride first time starters;
can not ride two year olds.
- **Stall Space:** Acceptance of stall space or entry of a horse in a race at Laurel/Pimlico constitutes an agreement by the trainer and owner to all terms and conditions of Laurel/Pimlico's current stall application, whether or not the application is signed.
- **Gate Fee:** All starters will pay a \$25.00 fee. These fees paid to the Association shall be for the account of the Maryland Horseman's Assistance Fund, to be used exclusively by it to assist needy persons connected with Thoroughbred racing.



HOUSE RULES

Preference Date Rules

1. Preference dates can be established by one of the following:
 - a. Turning in foal papers into the racing office
 - b. Entering a race to run (NO date only entries)
2. Dates must be reestablished annually in January. Exact date will be announced
3. Turf and Dirt preference dates will be kept separately
4. Horses will receive an E date for both dirt and turf for the date the foal papers are turned in
5. Horses entering with no date and not getting in a race will receive an E date corresponding to the date of the race entered
6. Each time a horse runs, its previous date will be replaced by an R date corresponding to the date of said race.
7. Horses that scratch will receive an S date for the date of the race, UNLESS the race runs with a full field or they were an alternate, in which case they will retain their previous date
8. Horses with an established date that re-enter and still do not get in WILL keep their established date
9. If a race is switched from turf to dirt, those horses that stay in and run will get a star (*) date which will take precedence over any E, R, or S date
10. If a race is cancelled, those horses who came to run and do NOT scratch prior to cancellation, will get a star (*) date
11. Horses that came to run, but are scratched by the State Vet due to lameness prior to race will receive an S date
 - a. Pre-race exam
 - b. Paddock
 - c. Post parade
 - d. Starting gate
12. Horses that came to run, but are scratched due to unfortunate circumstances prior to race will keep their previous entry date
 - a. Got loose in stable area or on track
 - b. Starting gate mishap



HOUSE RULES

Preference Date Rules Cont'd

13. Horses who race in another jurisdiction (including all NSA sanctioned races) WILL lose all dates except during a break in the Maryland racing schedule exceeding 15 days.

a. If you run out of town, DO NOT send physical and/or digital papers back to Horse ID until the following day to re-establish a date in MD.

b. If you run out of town, but your papers remained on file in MD, it is your responsibility to re-establish your date the following day by contacting Horse ID.

14. A star date has first preference, then the oldest date takes precedence. For horses with the same date, an E date has first preference, and R date has second preference then an S date has third preference. If horses have the same date and category (E, R, or S), horses stabled in Maryland will have first preference then Maryland-Breds will have second preference

15. Preference dates are good for any type of race or distance for specific

surface date was established with the exception of stakes.

Stakes are NOT considered in the preference system

16. Preference dates WILL not supersede the conditions of the race

17. Claims, transfers, or private sales will NOT have an effect on preference date

18. Any horse in the body of a race at Laurel/Pimlico other than a stake is considered an In-Today horse and shall receive NO preference.

a. MTO horses are NOT considered In Today horses

19. If there is a coupled entry in a race, the second half of the entry will NOT be able to draw into the race at the exclusion of a single entry (stakes not included); if part of a coupled entry scratches it will retain its previous date if the other part of the entry runs



HOUSE RULES

Big Events Procedures

1. SCOPE

The following races are considered Big Events at MJC:

1. Barbara Fritchie Stakes
2. The General George Stakes
3. Black Eyed Susan
4. Preakness Stakes
5. Maryland Millions Classic
6. Breeders' Cup Races at MJC property
7. Breeders' Cup Future Stars Friday Races at MJC property

The days these races are held are considered Big Event Days. The above list is subject to change and the Racing Office will update the condition book accordingly.

2. PROCEDURES

There are two groups of horses on Big Event days. The first group is those horses that are racing in the Big Events (Big Event Horses). The second group are those horses racing in the undercard stake races that day (Undercard Stakes Horses). Each set of horses will be subjected to increased scrutiny and specific procedures.

The procedures for Big Event Horses are as follows:

1. All horses nominated to a Big Event are subject to Out of Competition Testing (OOCT). OOCT tests will be taken within the month of the Big Event and consist of blood, urine, and/or hair testing.
2. Trainers for Big Event Horses must provide the Equine Medical Director 14-days' worth of veterinary records 72 hours prior to the race. Daily veterinary records between 72 hours and the race must be provided to the Equine Medical Director. These records can be submitted to the MRC office or sent electronically to: Elizabeth.daniel@maryland.gov.
3. Big Event Horses must be on the grounds of the racetrack at which the event will occur a minimum of 72 hours prior to the Big Event. Horses may not stable at training facilities or other regulated facilities during this time – only at the Big Event location.
4. The Racing Office will provide Big Event Horses specific saddle towels that are numbered or include the horse's name to allow for identification of the horse during training. Towels will be provided to trainers or their designee on the day horses are required to arrive on the track.



Big Events Procedures Cont'd

HOUSE RULES

5. Big Event Horses must wear their designated saddle towel each day for training up to and including race day. The saddle towel number must not be obscured by other equipment and shall be visible to the Veterinary Team.
6. The Veterinary Team will inspect horses daily beginning the morning after the designated arrival time and continuing through and including race day. Horses should not be put in ice or bandages prior to the daily examination.

The procedures for Undercard Stakes Horses is as follows:

1. All Undercard Stakes Horses are subject to Out of Competition Testing (OOCT) consistent with local regulations.
2. Undercard Stakes Horses must be at a racing or training facility monitored by the Veterinary Team during training a minimum of 72 hours prior to post time for their scheduled race – this may include certain non-TSG facilities as determined by the Racing Office and CVO.
3. The Racing Office will provide Undercard Stakes Horses specific saddle towels that are numbered or include the horse's name to allow for identification of the horse during training. Towels will be provided to trainers or their designee on the day horses are required to arrive on the track or at the training facility.
4. Undercard Stakes Horses must wear their designated saddle towel each day for training up to and including race day. The saddle towel number must not be obscured by other equipment and visible to the Veterinary Team.
5. Undercard Stakes Horses will be monitored by the Veterinary Team during training.
6. The Veterinary Team shall examine horses on race day. Additional examinations may be conducted on the days preceding race day.

Graded Stakes, Two Year Olds, and Furosemide:

Beginning in 2020, all Two Year Olds that race at MJC properties are prohibited from receiving furosemide within 48 hours of post time. Beginning in 2021, all horses entered in Graded Stakes races at MJC properties are prohibited from receiving furosemide within 48 hours of post time.

Administration of furosemide at 48 hours or more may be done by the trainer's private veterinarian.



HOUSE RULES

Health Certificate to include Veterinary Inspection for EHV-1

Horses shipping into any MJC facility must have a Health Certificate with the following information before the horse will be allowed to come through the stable gate.

You must have a health certificate dated within 72 hours of arrival with a rectal temperature and a certificate of veterinary containing the following statement and signed by the attending veterinarian.

HORSES REPRESENTED ON THIS CERTIFICATE OF VETERINARY INSPECTION MUST:

- A. Have not originated from the barn with a confirmed or suspect case of EHV-1, nor have shown signs suggestive of this disease, nor have been febrile within the previous 3 weeks.
- B. Have not originated from nor been stabled on a premise under quarantine or restriction due to EHV-1 or from a premise which has had EHV-1 diagnosed during the previous 30 day period.
- C. Have been vaccinated against EHV-1 no less than 14 days and no greater than 180 days.

Safety and Welfare

1. Any horse required to work in order to be removed from the “vet’s” or “poor performance” lists shall work at least one half mile in 52.00 or better.
2. If a horse has not run in 45 days, it must have at least one (1) published work within 30 days.
3. First-time starters shall need three (3) published works



HOUSE RULES

within 60 days to be eligible to start in a race. One (1) work from the gate, and one (1) work at least a half-mile within 30 days of the race date. All first-time starters shall have a gate card on file with the racing office at the time of entry.

4. A horse that has not started in 90 days shall have at least two (2) published works within 60 days. One (1) of at least one-half-mile, and another within 30 days of starting.
5. A horse that has been off for more than 150 days shall be required to work three (3) times within 60 days. One (1) within 30 days of the race date, and one (1) work of at least one-half-mile. In addition, the horse shall not be allowed to start until the attending practicing veterinarian signs off that the horse is sound for racing and approval is obtained from the Equine Medical Director.
6. A horse that has been off for more than 180 days will need a six (6)-month card from the starter.
7. Trainers shall contact the clocker and provide the name of their horse that is going to work and the distance prior to the horse working. Failure to report to the clocker may result in disciplinary action. Requests for workout corrections can only be made within 48 hours. Check the work tab and contact the clockers if changes are necessary.
8. A horse scratched for a medical reason shall not work within 48 hours of being scratched.
9. Any horse vanned off or put on the vet's list during training or racing may not return to training or racing unless the attending practicing veterinarian consults with the Equine Medical Director to discuss the diagnosis of why the horse needed to be vanned off and signs off that the horse is sound enough to return to racing. The horse must also work for the State Veterinarian and have blood specimens analyzed.
10. All horses that have been off for more than a year must work for a State Veterinarian and have blood specimens analyzed.



HOUSE RULES

11. A horse observed to be lame by the State Veterinarian may be placed on the vet's list at the discretion of the Equine Medical Director for an amount of time determined by the Equine Medical Director. A horse observed to be lame a second time within 365 days of the first time shall be ineligible to race for 90 days, and in the case of a third occurrence within 365 days, the horse shall no longer be eligible to run.
12. A horse observed to be lame by the State Veterinarian may be placed on the vet's list at the discretion of the Equine Medical Director for an amount of time determined by the Equine Medical Director. A horse observed to be lame a second time within 365 days of the first time shall be ineligible to race for 90 days, and in the case of a third occurrence within 365 days, the horse shall no longer be eligible to run.
13. A horse scheduled to run within 7 days of its previous start shall be flagged for additional scrutiny.
14. If an "override" is required to take an entry of a horse, that horse may not be permitted to start until the Equine Medical Director approves.
15. Any horse found to have been treated with bisphosphonates shall be declared ineligible to run. Any veterinarian found to have administered bisphosphonates to a horse shall be subject to disciplinary action.
16. Any horse entered in a race is not permitted to leave the grounds.
17. No 6-year-olds and upward maidens will be allowed to start.
18. No horses older than 10 years old will be permitted to enter.



HOUSE RULES

The Veterinarian's List

A horse placed on the Veterinarian's List as being unfit to race or have a timed workout may be released from the list only after the following conditions have been met:

- Has been on the Veterinarian's List a minimum of 10 days, unless that requirement is waived by a commission veterinarian;
- For horses that are listed as unsound or lame:
 - o Undergo a pre-workout examination by the attending veterinarian and be cleared by that veterinarian to work off the vet's list;
 - o Provide a published workout of a minimum of four furlongs in :52, observed by a commission veterinarian;
 - o Undergo a post-workout examination by the commission veterinarian;
 - o If the horse is deemed to be sound following the workout, submit to a blood test;
 - o If the horse is deemed to be unsound before or after the workout, the stay on the Veterinarian's List will be extended to a minimum of 30 days, and diagnostic testing may be required.
- For horses placed on the list for injury, illness, physical distress or heat exhaustion; or for a positive test or overage, administration of a medication invoking a mandatory stand down time, administration of shock-wave therapy, positive out-of-competition test, or any other veterinary administrative withdrawal:
 - o Undergo an examination to demonstrate that the horse is serviceably sound and in fit physical condition to exert its best effort in a race or timed workout;
 - o May be required to work at the discretion of the chief regulatory veterinarian.



Maryland Jockey Club Stable Area/Barn Safety and Environmental Rules

HOUSE RULES

- Smoking (and other sources of ignition) is (are) prohibited in and immediately outside of all barns
- Chemicals (especially flammables and combustibles) must be properly labeled, handled, and stored.
- Chemical/fuel spills and/or leaks must be reported to MJC security
- Electrical equipment/appliances must be unplugged when not in use
- Access to fire sprinkler equipment and controls must be kept clear
- Nothing should be attached to or hung from any fire sprinkler system component
- Areas around hot water heaters and boilers (and other sources of heat) must be kept clear of flammable and combustible materials
- Manure (straw and shavings) must be placed in proper bins
- Manure (straw and shavings) and fresh shavings bins must be covered when not in use
- Areas outside of barns must be swept up; not hosed down
- Storm water inlets and basins must be kept clear of dirt, straw and shavings etc.
- All soaps and detergents used in the stable area must be biodegradable
- Horse wash stalls must be used where provided
- Water must not be allowed to run freely when not in use
- No dumping of water buckets in stalls
- Hoses must have a functioning nozzle or be turned off when not in use
- Washing machines are not permitted in the barns
- Trash must be placed inside dumpsters; not along side
- No throwing of trash in stalls
- Trash must not be placed in manure bins
- Dumpsters must be closed/covered when not in use
- All pony people escorting horses to the post must wear the required attire. Proper attire will be strictly enforced by the outriders
- There will be no riding in the barns after 11:00 am. If you are caught riding in the shed row after 11:00 am you are subject to a fine.

No oat cookers are allowed on the grounds.



HOUSE RULES

Racetrack Safety Rules and Procedures

1. Listen and obey the outriders instructions at all times.
2. When the lights are activated during training hours, immediately pull your horse up to a jog. Turn your horse in the same direction as the loose horse.
3. Do not enter the track when the safety lights are activated.
4. Do not continue to gallop or jog when emergency vehicles are on the track.
5. When emergency vehicles (horse or human ambulance) are on the track, you must safely get off the track at the nearest gap.
6. Do not gallop the wrong way on the racetrack. No more than two abreast on the outside rail.
7. Do not jog the wrong way past the starting gate when the gate is set.
8. Do not gallop or jog on/off the gaps.
9. Do not gallop or jog on the horse paths.
10. No galloping on the rail.
11. Be courteous of other riders; let them know when you are passing (no buzzing).
12. You must have a current, exercise rider license in order to gallop on the race track.
13. While on horseback, you must wear a fastened, approved safety helmet and vest, and proper riding footwear that has a heel and sole.
14. No free ponying the wrong way on the race track.
15. Young, green horses should go on the racetrack as late in the morning as possible.

VIOLATORS MAY BE SUBJECT TO A FINE OR LOSS OF EXERCISING PRIVILEGES AT ANY MJC FACILITY.



HOUSE RULES

Bisphosphonates Prohibition

The entire Mid-Atlantic region will impose, and strongly urges all Thoroughbred industry stakeholders and regulators to support, the enactment of an immediate prohibition on the use of bisphosphonates in all horses under the age of 4, unless and until the scientific and veterinary community determines that the use of such drugs does not compromise the health and welfare of the horse. The use of bisphosphonates in horses 4 years old and older should be limited to only those horses who have been diagnosed with navicular disease by a veterinarian and for whom the use of such drugs is warranted.

Joint Injections Concerning Horses Claimed

Concerning a claimed horse: As of January 1, 2016, The trainer of record of a horse that was claimed shall have his Veterinarian supply the Maryland State Vets within 72 hours, a report in writing or email the joint(s) injection(s) performed on said animal within the last 30 days. Report will include joint (s) involved, medication used (Depo-Medrol, Hyaluronic acid, etc.) and the dose used. This data will be shared with the party who claimed said animal.

Claim Barn

Every claimed horse not subjected to testing will now be sent to the "CLAIM BARN" for observation by the state veterinarian for a period up to one hour. The original groom will be required to bring the claimed horse to that barn and stay with them until released. Claimed horses will be observed cooling out and required to jog for the state

veterinarian. The horse will then either be cleared to leave with the new owner's groom or the claim will be voided.

Equine Injury Database

In consideration of the acceptance of a nomination of any horse to any race described in this condition Book, the owner(s) and trainer of such horse consent to the collection of information related to any equine injury occurring at the Laurel Racing Assoc. Inc. ("Laurel") or The Maryland Jockey Club of Baltimore City, Inc. ("Pimlico") or Bowie Training Center ("Bowie") to such horse and entry of said information into a database maintained by The Jockey Club (the "Equine Injury Database"). Said owner(s) and trainer further agree to indemnify, release, hold harmless and covenant not to sue The Stronach Group and the Laurel Racing Assoc. Inc. ("Laurel"), The Maryland Jockey Club of Baltimore City, Inc. ("Pimlico"), and Bowie Training Center ("Bowie"), any state or track-appointed veterinarian collecting such information and The Jockey Club (collectively, the "Indemnified Parties") from and against any liability, cost, loss, or expense of any kind or nature (including, without limitation, reasonable attorneys' fees) arising from any claim, demand, or action (a) alleging that the data entered into the Equine Injury Database (either directly or indirectly) violates the rights of the owner(s), trainer or any third party, or (b) relating to any equine injury report run, published or otherwise created by any of the Indemnified Parties, including the owners, stewards, directors, officers, employees and agents of any of them (either directly or indirectly).

Flu/Rhino Vaccination

All horses and ponies that enter an MJC facility must have been given the flu/rhino vaccination within 180 days and no less than 14 days, and have their vet report the name of the horse and date the horse was vaccinated to the racing office.

Reporting Horse Gender

A trainer is responsible for reporting the proper gender of his or her horse at the time of entry, and reporting the CASTRATION of any horse in his or her care to the horse identifier. Violators will be assessed a \$250 FINE by the stewards for failure to report castrations at the time of entry.

Blinkers

To be used in a race, blinkers must have a minimum one-half inch cup.

Slaughterhouse/Auction House Policy

Any trainer or owner stabling at a Stronach Group facility, or any auxiliary stabling area, found to have directly or indirectly participated in the transport of a horse to either a slaughterhouse or an auction house engaged in selling horses for slaughter, will be prohibited from having stalls and racing at any Stronach Group facility.

Two Year Olds

Two year olds may not race until after their actual two year old birthday.

Cobalt Threshold

1) A horse which tests between 25 nanograms per milliliter of blood plasma or serum and 50 nanograms per milliliter of blood plasma or serum shall be placed on the vet's list and not be permitted to start in a race until the horse tests below 25 nanograms per milliliter of blood plasma or serum. All costs associated with any retesting shall be paid for by the owner of the horse.

2) A horse that exceeds 50 nanograms per milliliter of blood plasma or serum shall be disqualified, the trainer of the horse shall be suspended and/or fined at the discretion of the Stewards or Judges and assessed points under the multiple medication violation point system. As previously stated, the horse shall be placed on the vet's list and not permitted to start in a race until the horse tests below 25 nanograms per milliliter of blood plasma or serum. All costs associated with retesting the horse shall be paid for by the owner of the horse.

Starting February 1, 2020 Lasix Restricted To 4 Hours

Administration of Furosemide (Lasix) shall be restricted to four (4) hours prior to post time of the horses race. A horse not meeting the four (4) hour restriction shall be scratched.

Horses shipping in to run are advised to be on the ground five (5) hours before scheduled post time to meet the Lasix administration requirement and to be pre-raced checked.

TURF WORKS

Sundays - weather permitting

9:15 - 10:00am

Working on the turf will require a \$150 fee which must be paid for before a turf workout. All turf sign ups must be submitted to the racing office by 12 Noon Saturday before turf works on Sunday. Sign-ups are a first-come, first-serve basis and a maximum of 20 horses will be allowed to work on the turf.

1st preference will be to stake horses

2nd preference will be to allowance horses

3rd preference will be to claiming horses
(winners)

4th preference to maidens

The racing office has final say on who is allowed to work on the turf and reserve the right to deny a workout.

The monies will be used toward backstretch workers and the Beyond The Wire Maryland Thoroughbred Aftercare Program.

COUPLED HORSES

As of October 25, 2018 Coupling Rule:

11) Coupled Horses.

(a) In §F(11) of this regulation, “commonality of ownership” means that the same person, persons, entity, or entities own at least 25 percent of a horse entered in a race and also own at least 25 percent of another horse entered in the same race.

(b) Except as provided in this subsection, horses [shall] may be [coupled] uncoupled at the time of entry for betting purposes if the horses have commonality of ownership.

(c) If a race is split into two or more divisions, horses [required to be coupled under] subject to the provisions of §F(11)(b) of this regulation shall be seeded in separate divisions, if possible, but the divisions in which they compete and the post positions shall be determined by lot.

09.10.01.17

Z. Declaration in Purse Races and Overnight Handicaps.

(1) The stewards may, for cause, allow a horse to be declared out of a race.

(2) If a horse is declared out of a race under the provisions of §Z(1) of this regulation, the stewards shall prohibit the horse from running out-of-State for a period up to 10 days starting with the day of the race from which the horse was declared out.

(.09.10.01)(26). A horse is a “starter” when the stall doors of the starting gate open in front of the horse at the time the starter dispatches the field.

Barred Horses (.09.10.04.12)(A). Barred Horses. If a trainer has in the trainer’s charge a horse whose name appears on a veterinarian’s, starter’s, steward’s, or judge’s list or any other list of horses ineligible to start, commonly known as a “Barred List”, at a race track outside this State, the trainer shall report the name of the horse and the fact that the horse has been barred to the Racing Secretary, as well as to the stewards or judges, at the meeting within the State at which the trainer proposes to enter the horse to race.

Denerved Horses (.09.10.04.13)(A). Denerved Horses or Horses Subjected to a Cryosurgical Procedure. A denerved horse or a horse subjected to a cryosurgical procedure shall be registered with the chief veterinarian on a form provided by the Commission for that purpose.

Claiming. (.09.10.01.07)(A). Except as provided in §A-1 of this regulation, in claiming races a horse is subject to claim for its entered price by: (1) through a licensed owner; (2) An individual authorized to claim in behalf of a registered stable or other multiple ownership entity; or (3) A registered authorized agent in behalf of a person listed in §A(1) or (2) of this regulation. A-1. In claiming races a horse is not subject to claim if: (1) The horse has not started for a minimum of 120 days; (2) The last start of the horse was a claiming race; (3) The horse is entered for a claiming price not less than the claiming price of its last start; (4) For the first race following the period specified in §A-1 (1) of this regulation, the horse is declared ineligible to be claimed at the time of entry; and (5) The program clearly designates that the horse is ineligible to be claimed. **(B).** Eligibility to claim. (1) Except as provided in §A-1(2) of this regulation, to be eligible to claim, a licensed owner, registered stable, other multiple ownership entity shall designate, as the person who will assume control and responsibility of a claimed horse, a licensed trainer who has been assigned stabling on the grounds under the jurisdiction of the Commission. (2) A licensed owner, registered stable, or other multiple ownership entity that does not have a licensed trainer with assigned stabling on grounds under the jurisdiction of the Commission is eligible to claim only to replace a horse lost to a claim at a track under the jurisdiction of the Commission. **(C.) A person may not be eligible to claim more than one horse in a race, either directly or through another.** **(D).** A valid claim shall: (1) Be in writing on a form provided by the association; (2) Be in the name of a person qualified to claim a horse; (3) Be signed by the person, or the agent of the person, in whose name the claim is made; (4) Contain the name of the horse to be claimed in a manner sufficient to avoid confusion with the name of another horse in the race; **(5) Name the trainer who will assume control and responsibility of the horse to be claimed;** (6) Be for the amount printed in the program as the claiming price of the horse; (7) Be enclosed in a sealed envelope, provided by the association, which shall contain no identifying marks on its outside other than the number of the race in which the claimed horse is to participate; (8) Be deposited in the time lock box of the claims clerk at least 10 minutes before the post time for the race in which the claimed horse is to participate; (9) Be supported by funds on deposit at the association in the name of the claimant in an amount sufficient to cover the cost of the claim and any taxes to which the claim may be subject. **(E).** After the deadline for entering a claim has passed, the stewards or designee shall: (1) Open the claim envelope for the race; (2) After ascertaining compliance with §§D and E of this regulation, if there is more

than one valid claim for a horse, conduct a public drawing to determine the successful claimant; and (3) Notify the Racing Secretary of the identity of the successful claimant and the horse claimed. **(F)**. The stewards may require a person who submits a claim for a horse in a claiming race to make an affidavit declaring that the person is claiming the horse for the person's own account or for the account of another as the registered authorized agent for that person. **(G)**. If the stewards determine that a horse was improperly entered in a claiming race, they may; (1) Void a claim of the horse; (2) Order the claiming monies, including all taxes, refunded to the claimant through the Clerk of the Course, the horsemen's bookkeeper, or otherwise; and (3) Order the return of the horse to the original owner.

(.09.10.01.07)(H). Except as provided in §H-1 of this regulation, unless there is a violation of this regulation by the claimant, or the stewards determine that a horse was improperly entered: (1) The claim is irrevocable and the claimed horse becomes the property of the successful claimant from the time the horse is a starter; and (2) A purse earned in the race from which a horse is claimed is the property of the owner from whom the horse is claimed.

(.09.10.01.07)(H-1) A claim shall be voided if a horse is a starter and the horse: (1) Dies on the racetrack; or (2) Suffers an injury which requires the euthanasia of the horse, as determined by a State veterinarian, while the horse is on the racetrack.

(.09.10.01.07)(H-2) A claim is voidable at the sole discretion of the new owner, for a period of 1 hour after the race is made official, for any horse that: (1) Is vanned off the track after the race at the discretion of the State Veterinarian; or (2) Is sent to the detention barn and observed to be lame by the State Veterinarian.

Notice - There are two ways to void a claim in the above circumstance:

1. An owner, his trainer or authorized representative can elect to void the claim by checking a box for that purpose on the new Maryland Claim Form. If you have no intention of keeping a horse that is vanned off the racetrack you should check this box when you submit the claim.
2. There will be a new Void The Claim Form available in the racing office. If you have claimed a horse that is vanned off the racetrack at the direction of the State Veterinarian and did not elect to automatically void the claim on the Claim Form and you do not want the horse, you will have 1 hour after the race is declared official to file with the racing office a completed Void The Claim Form. If timely filed and approved by the Stewards, the claim will be voided.

For the claim of any horse vanned off the racetrack during the running of a race at the direction of the State veterinarian that does not satisfy either of the above requirements, ownership of the horse passes to the claimant.

(.09.10.01.07)(I). After the race has been run, the successful claimant shall present verification of the claim by the Racing Secretary to the person accompanying the claimed horse.

(.09.10.01.07)(J). A properly claimed horse shall be delivered to the successful claimant in the: (1) Paddock, immediately after the running of the race, if the horse is not subject to post-race testing; or (2) Detention area, after the horse has undergone post-race testing, if the horse is subject to that testing.

(.09.10.01.07)(K). If a trainer refuses to deliver a horse that has been claimed to the successful claimant when verification of the claim is presented in accordance with §J of this regulation, the: (1) Trainer is subject to sanctions; and (2) Claimed horse shall be disqualified from participating in further racing

until delivery is made.

(.09.10.01.07)(L). In claiming races, the following acts, or an attempt to commit the following acts, are prohibited: (1) An agreement to claim, or not to claim, a horse belonging to another owner; (2) Preventing an owner from: (a) Claiming a horse, or (b) Legitimately running a horse in a race; (3) The claiming of a horse by: (a) The owner of the horse, (b) Another person for the account of the owner of the horse, or (c) One owner from another if the trainer of the horse to be claimed trains a horse owned by the entity making the claim; and (a) A lien or other encumbrance affecting the transfer of title to the horse unless there is written permission from the holder of the lien or other encumbrance, attached to the horse's foal certificate, allowing the horse to be entered in a claiming race; (b) An ownership dispute, or (c) A written prohibition of the horse being entered in a claiming race which is attached to its foal certificate.

(.09.10.01.07)(M). If a horse is claimed: (1) For a period of 30 days from the day of the claim, the horse may start in a claiming race only for a claiming price at 25% more than the claiming price for which it was claimed; (2) The horse may not be sold or transferred to anyone, wholly or in part, for a period of 30 days from the day of the claim, except: (a) In a claiming race, or (b) When the horse is entered and starts for a claiming price which would cause the horse to become ineligible to be entered at Laurel or Pimlico; (3) Unless reclaimed, the horse may not remain in the same stable or under the control of management of its former owner or trainer for a period of 30 days from the day of the claim; (4) It may not race outside of Maryland for a period of 60 days from the day of the claim except: (a) To participate in a stake; (b) To participate in a claiming race for a price which would cause the horse to become ineligible to be entered at Laurel or Pimlico; or (c) During the scheduled absence of a live thoroughbred race meet in Maryland for at least 15 days.

(.09.10.01.07)(N). For the purposes of §M of this regulation, the day of the claim does not count in computing the time restrictions.

(.09.10.01.07)(O). The stewards shall report action taken by them, in reference to a violation of this regulation, to the Commission which may, in its discretion, take any further action it considers appropriate.

(.09.10.01.07)(P). A horse which was claimed in another state and entered to race in this State remains subject to the conditions of the claiming regulation in the state where the claim was made until those conditions expire.

(.09.10.01.07)(Q). Notwithstanding information printed in the program or other racing publications, the claimant is solely responsible for determining the horse's: (1) Age; (2) Breeding; (3) Physical condition; (4) Racing record; and (5) Sex.

Definitions. (.09.10.03.01)(A). In this chapter, the following terms have the meanings indicated.

General. (.09.10.03.03)(A). Except as provided in §A(14) of this regulation, the following acts are prohibited if committed on the grounds of a facility under the jurisdiction of the Commission, if they affect a race conducted live in the State, or if they affect the betting on a race in this State: (1) Offering, promising, giving, accepting, or soliciting a bribe in any form, directly or indirectly, to or by a person having any connection with the outcome of the race; (2) Entering, or knowingly aiding and abetting in the entering of, a horse ineligible or unqualified to race; (3) Participating in any improper, corrupt, or fraudulent act or practice in relation to racing; (4) Causing, attempting to cause, or any participation in an attempt to cause the prearrangement of a

race result; (5) Soliciting bets on a horse from the public by a licensee either by correspondence or other methods; (6) Using or possessing a battery, buzzer, electrical device, or other appliance, other than an ordinary whip, which could be used to alter the speed or racing condition of a horse in a race or workout; (7) Using profane, abusive, or insulting language to employees of the Commission, employees of a facility under the jurisdiction of the Racing Commission, or the public; (8) Being in an intoxicated state; (9) Fighting or other conduct of a disorderly nature; (10) Using or possessing a deadly weapon; (11) Committing or participating in the commission of a criminal act; (12) Violating a regulation or condition of the Commission or aiding or abetting a person in the violation of a regulation or condition of the Commission; (13) Failing to comply with an order or ruling of a steward, judge, or other racing official pertaining to a racing matter; (14) Cruelty to a horse wherever committed; (15) Tampering, or attempting to tamper, with a horse for any purpose; (16) Transferring, or attempting to transfer, the ownership of a horse for a purpose other than its legitimate sale or lease; (17) Registering a horse under the name of a person other than the legitimate owner or lessee of the horse; (18) Making false or misleading statements to a racing official or submitting false or misleading statements on a license application; (19) Except as otherwise provided in this regulation, using or possessing, actually or constructively, any of the following items: (a) A drug, or (b) A hypodermic needle, hypodermic syringe, or other device which could be used for injection; (20) Using or possessing the ingredients or the paraphernalia associated with the forced feeding to a horse of a combination of baking soda and sugar, or a form of sugar, or administering a substance by tubing within 24 hours of a racing program in which a horse is scheduled to race; (21) The possession or administration of Erythropoietin or any analogous substance that increases the oxygen carrying capacity of the blood; and (22) Failing to report the knowledge of a violation of this regulation to the stewards, judges, or the Commission.

(.09.10.03.03)(B). The use or possession of the items listed in §A(19)(a) and (b) of this regulation is permissible if the: (1) Item is possessed or used for a legitimate purpose by a licensed veterinarian; (2) Item is possessed or used pursuant to a valid prescription or order from a medical practitioner while acting in the course of the practitioner's professional practice; or (3) Stewards or judges, in their discretion, grant permission authorizing the possession or use of the item.

(.09.10.03.03)(C). The use of a shockwave therapy device is prohibited unless: (1) The device is registered with the Commission Veterinarian; (2) The device is used by a licensed veterinarian; (3) The device is used on a horse at least 30 days before the horse participates in a race; and (4) Each use of the device is reported to the stewards on a daily medication report as provided in COMAR 09.10.01.47K and 09.10.02.39F(3) and (4).

Drug Prohibition - Horses. (.09.10.03.04)(A). An individual may not administer, cause to be administered, participate, or attempt to participate in any way in the administration of a drug to a horse (1) During the 24-hour period before the scheduled post time for the first race of the program in which the horse is to participate; and (2) Until after the race in which the horse is programmed to participate is run.

(.09.10.03.04)(B). Notwithstanding any other provision of this chapter, no substance of any kind may be administered to a horse within 2 hours of the scheduled post time for the race in which the horse is entered.

(.09.10.03.04)(C). A horse participating in a race may not carry a drug in its body.

(.09.10.03.04)(D). The presence in the post-race urine, blood or other sample

taken from a horse is prima facie evidence that the: (1) Horse was administered a drug and carried the drug in its body during the race; and (2) Drug was administered by the person or persons having control, care, or custody of the horse.

(.09.10.03.04)(F). Trainer Responsibility. A trainer is the absolute insurer of, and responsible for, the condition of each horse the trainer enters in a race, regardless of the acts of third parties.

(.09.10.03.04)(G). Enforcement. (1) The stewards or judges may order the: (a) Post-race taking of urine, blood, or other samples for testing purposes from any horse which participated in a race; (b) Denial, forfeiture, and prompt return of a purse, sweepstakes, trophy, or any other reward received by the owner of a horse found to have carried a drug in its body during a race; (c) Redistribution of the items denied, forfeited, and returned, resulting from the disqualification of a horse found to have carried a drug in its body during a race, to those owners whose horses were advanced by the disqualification. (2) If the stewards or judges order a disqualification due to a horse having carried a drug in its body during a race, they shall issue a ruling announcing the disqualification.

(.09.10.03.04)(H). Repeat Violations. An individual guilty of violating this regulation, or a comparable regulation of another racing jurisdiction, for the second time is considered a repeat offender, and the stewards, judges, or the Commission shall weigh this factor in determining a sanction.

Search and Seizure. (.09.10.03.07)(A). The stewards, judges, or designated Commission representatives have the right to enter into or upon the buildings, stables, rooms, automobiles, or any other place within the grounds of a facility under the jurisdiction of the Commission for the purposes of examining them, as well as the personal property and effects of a licensee contained there for the purpose of searching for, and the seizure of, items that constitute evidence of a violation of this chapter.

(.09.10.03.07)(B). An individual who has been granted a license by the Commission, by accepting the license, consents to a search and seizure as provided in §A of this regulation.

(.09.10.03.07)(C). A licensee who refuses to permit a search may be disciplined.

Bleeders. (.09.10.03.08)(A). The administration of Lasix to a horse is permissible if: (1) The administration of Lasix is recommended by a practicing veterinarian; (2) The recommendation is submitted to the State Veterinarian in writing; and (3) The trainer declares the use of Lasix at the time of entry.

(.09.10.03.08)(B). A Commission veterinarian is responsible for maintaining up to date records of horses which are permitted to use Lasix, and these records shall be available for inspection during the hours of operation of a race track.

(.09.10.03.08)(C). If a horse has been observed by a Commission veterinarian to have bled from at least one nostril during the running of a race or workout, either on the racing strip or in the barn area, that horse may not be permitted to race for a period of 14 days.

(.09.10.03.08)(D). If a horse has been observed to have bled as described under §C of this regulation within 365 days of the first occurrence, that horse: (1) May not race for 30 days after the first reoccurrence; (2) May not race for 180 days after the second reoccurrence; and (3) Is banned from racing forever after the third reoccurrence.

(.09.10.03.08)(E). For the purpose of counting the number of days a horse is not permitted to race in this State under this section, the day the horse bled is the first day, and the horse shall be permitted to race in the State when the last day has expired.

(.09.10.03.08)(G). Racing Off of Lasix. (1) A horse on the Lasix Program that races without Lasix in any jurisdiction which permits the use of Lasix may not be eligible for its use for a period of 60 days. (2) To become eligible after 60 days: (a) The horse shall have been observed to have bled by a Commission veterinarian either: (i) Externally; or (ii) By endoscopic examination.

(.09.10.03.08)(H). Program Notice. (1) Of the horses scheduled to race, the official program shall denote the horses which have been administered: (a) Lasix; (b) Lasix for the first time (2) In the official program contains past performance lines, each past performance line shall indicate if the horse was administered; (a) Lasix.

Equine Specimen Testing. (.09.10.03.09)(A). The stewards or judges may designate a horse entered in a race to give blood or urine sample, or both, before or following the race.

Engagements and Transfers (.09.10.01.16)(A). In Maryland, if a horse is sold by private treaty or at public auction, or claimed out of claiming race (unless the conditions of the claiming race stated otherwise), it is considered to be transferred with all its engagements. The written acknowledgment of both parties is necessary to prove otherwise.

(.09.10.01.20)(B). A horse may not be allowed to race unless it has been lip tattooed by the Thoroughbred Racing Protective Bureau (TRPB). For good cause, the stewards or judges may waive this requirement if the horse is otherwise properly identified. However, the horse shall be tattooed thereafter within a time set by the stewards or judges.

(.09.10.01.17)(N). To compete in a race, a horse shall be eligible at the time of starting for that race.

License Badges (.09.10.04.11)(A). A licensed individual who enters a stable area which is under the jurisdiction of the Maryland Racing Commission shall wear upon the individual's outside apparel, in a prominent position, the license badge issued to the individual by the Commission, which contains the individual's picture identification.

Owners (.09.10.01.28)(F-1). Multiple ownership. Forms of multiple ownership shall be duly licensed by the Commission before being allowed to start a horse.

Safety Equipment (.09.10.01.51). An individual, astride a horse or pony on the grounds of a facility under the jurisdiction of the Maryland Racing Commission, shall wear a: **(.09.10.01.51)(A).** Safety helmet which is designed to adequately protect the head from injury; and

(.09.10.01.51)(B). Safety vest which is equal to or exceeds the requirements set forth in Regulation .21-1 of this chapter.

(.09.10.01.57)(P-1). Substitute and assistant trainers. If a trainer is to be absent from the track where his horses are participating in races, he shall obtain a licensed trainer to substitute for him during his absence. The substitute trainer shall be approved by the board of stewards upon forms approved by the Racing Commission. The original trainer is the absolute insurer of the

horse he has entered. The substitute trainer will then become the absolute insurer of any additional horses he may enter.

(.09.10.01.57)(S). Any trainer or owner who harbors anyone not provided with a Maryland occupational license shall be immediately reported to the stewards, so they may make investigation thereof and take appropriate action as they deem necessary, if any, as provided under Regulation .45V.

Worker's Compensation (.09.10.04.19)(A). A person applying for a license who employs one or more individuals in a racing related activity shall have Workers' Compensation insurance as required by Maryland law unless the applicant's sole employee is a spouse.

(.09.10.04.19)(B). An applicant for a license under §A of this regulation shall list the following on the license application: (1) Name of the insurance company; (2) Name of the agent; (3) Policy number; and (4) Policy expiration date.

.09.10.04.19)(C). A licensee shall notify the Commission in writing, not less than 5 days before the effective date, of: (1) A change to the information furnished under §B of this regulation; (2) The cancellation of the policy; or (3) The nonrenewal of the policy.

.09.10.04.19)(D). A licensee, not employing one or more individuals in a racing-related activity when the licensee applied for a license, but who subsequently becomes the employer of one or more of these individuals, shall immediately: (1) Obtain the required insurance coverage; and (2) Furnish the Commission licensing office with the information required under §B of this regulation.

MEDICATION REFORMS EFFECTIVE JANUARY 1, 2014

The Mid Atlantic racing states have joined together to implement a uniform medication and drug testing program.

The following new rules and procedures are effective as of January 1, 2014 in Maryland.

1. Salix® (furosemide), pursuant to Commission supervised administration, is the only medication that can be administered to a horse within 24 hours of its race.

2. The administration of any adjunct medication within 24 hours of a horse's race is strictly forbidden.

3. There is a new medication category called **Controlled Therapeutic Substances**. This category contains a list of 24 therapeutic medications that have been recognized as necessary in the routing treatment of illness or injury in the horse. Withdrawal time guidance and uniform laboratory detection thresholds for these medications are being provided as a safe harbor for horsemen. You are strongly encouraged to restrict your use of medications to those on the Controlled Therapeutic Substances list, which will be amended from time-to-time.

PLEASE NOTE - All horses used in the administration studies exceeded 1,000 lbs. When dosing a horse smaller than 1,000 lbs., trainers and veterinarians may need to consider decreasing the total dose or increasing the time of dosing prior to racing.

4. Although five nonsteroidal anti-inflammatory drugs (NSAIDs) are contained on the Controlled Therapeutic Substances list - diclofenac, firocoxib, flunixin,

ketoprofen, phenylbutazone - they should not be used in combination and only one of these NSAIDs may be present in a post-race sample.

5. It is recognized that there are medications that may be used in the treatment of illness or injury in the horse that are not on the Controlled Therapeutic Substances List and for which no treatment guidance or uniform testing levels are provided. **Horsemen and veterinarians are strongly cautioned to withdraw a horse from racing for a sufficient period of time after the administration of a medication not on the Controlled Therapeutic Substances list to ensure against a positive drug test.** Substances that do not affect the organ systems of a horse such as antibiotics, antimicrobials, vaccines, etc. (except for procaine penicillin and levamisole) are not prohibited and are not the subject of testing.

6.(1) As of March 1, clenbuterol will not have a permissive threshold. The presence of the substance in a blood or urine sample—at any detectable level—will constitute a violation. A horse found with clenbuterol in its system will be disqualified and the trainer subject to disciplinary action.

The Racing Medication and Testing Consortium has recommended that clenbuterol not be administered to a horse within 28 days of a race at a minimum.

Because clenbuterol is recognized as a therapeutic medication, the regulation allows for its use if the following conditions are met:

a. The prescription for clenbuterol is made for a specific horse based upon a specific diagnosis. The prescription and volume dispensed cannot exceed a treatment period of 30 days.

b. The veterinarian must provide a copy of the prescription and diagnosis to the Equine Medical Director for review and approval. The horse may not receive clenbuterol before this approval is issued.

c. Trainers must make daily notification to the official veterinarian of horse(s) in their custody having been administered clenbuterol. Notification shall be made on a form and by a deadline designated by the Maryland Racing Commission.

d. A horse administered clenbuterol shall be placed on the official veterinarian's list. The horse must meet all conditions for removal from the list including a timed workout and blood and urine sampling. Both samples must have no detectable clenbuterol.

e. A horse may not enter to race until it has completed all the requirements in subdivision (d).

6.(2) If a clenbuterol is detected in a horse's post-race or out-of-competition sample and appropriate notification as outlined in subdivision 1(a) or (b) was not completed, the horse shall immediately be placed on the official veterinarian's list pending the outcome of an investigation. The horse shall be required to meet all conditions for removal from the veterinarian's list outlined in subdivision 1(d), above.

7. No intra-articular injection may be administered to a horse within 14 days of its next race. Administration of a total dose of 100 mg methylprednisolone acetate (Depo Medrol®) in one articular space will take approximately 21 days for the drug to fall below the testing detection level in plasma. For this and other reasons, **we strongly caution against the use of Depo Medrol® in the racing horse for at least 21 days prior to its race.**

8. During 2014, a new penalty system designed to identify and penalize those who incur multiple medication violations will be implemented. Each medication violation will incur points. Medication violations in the Controlled Therapeutic Substances category will be identified as Controlled Therapeutic

violations and not “positive tests” and these violations will have a lesser point value. Violations for drugs and medications not on the Controlled Therapeutic Substances list will incur double points. Trainers risk additional mandatory suspensions if they reach the points thresholds established under the model rule for multiple medication infractions.

THIRD PARTY LASIX ADMINISTRATION PROCEDURES

Effective January 1, 2014, the administration of Salix® (furosemide), to a horse on race-day will be by a Maryland Racing Commission designated veterinarian and according to the following rules and procedures:

1. The only medication allowed to be administered to a horse within 24 hours of its race is Salix® (furosemide).
2. The administration of any adjunct medication within 24 hours of the horse's race is strictly forbidden.
3. The primary change from the current practice in the administration of Salix® to a horse is that a Commission designated veterinarian who does not practice on the grounds will be administering Salix®.
4. All horses shall be administered Salix® on the grounds of the operating racetrack in their assigned stall.
5. All horses declaring the use of Salix® must be on the grounds of the operating track at least 5 hours prior to post time for their race.
6. Trainers or their representative not requesting the use of Salix® shall declare their horse off of Salix® at the time of entry.
7. Trainers or their representative are responsible to contact and inform the Salix® Clerk at the operating track the dosage of Salix® their horse is to receive.
8. The Salix® Clerk will prepare a list of all horses scheduled to receive Salix®, their dosage and their location at the operating racetrack.
9. The Veterinarian designated to administer Salix® will identify the horse by its tattoo number, record the dosage and time of administration for each horse treated and make a written report to the Stewards and the State Veterinarian.
10. Trainers are responsible for having their representative present and available when the designated Veterinarian arrives to treat their horse.
11. If the Veterinarian designated to administer Salix® cannot locate a horse for treatment or the trainers representative, the Veterinarian will contact the stewards and relay the information.
12. Consistent with current practice, it is recommended that a horse receive Salix® 5 hours prior to its race, at a dosage between 2 cc's and 10 cc's. **Salix® will be administered IV only.**
13. Under no circumstance will Salix® be permitted to be administered to a horse within 4 hours of its race.
14. Consistent with current practice, a horse that is entered on Salix® and does not receive Salix® will not be permitted to run.

15. The State Veterinarian will continue to be responsible for determining a horse's eligibility for the use of Salix® and also obtaining and verifying the proper documentation for a first-time Salix® horse.

.10 Out-of-Competition Testing.

A. The Commission may, at a reasonable time on any date, take blood, urine, or other biologic samples from a horse to ensure compliance with applicable medication and anti-doping standards set forth by the Association of Racing Commissioners International, Inc., as such standards may be amended and updated from time to time. The Commission shall own such samples. This regulation authorizes only the collection and testing of samples and does not independently make impermissible the administration to or presence in any horse of any drug or other substance. A race day prohibition or restriction of a substance by the Commission's regulations is not applicable to an out-of-competition test, unless there is an attempt to race the horse in a manner that violates such regulations.

B. Horses Eligible for Testing.

(1) Any horse that has been engaging in activities related to competing in horse racing in the State may be tested. This includes, without limitation, any horses that are training outside the State to participate in racing in the State, and all horses that are training in the State, but excludes weanlings, yearlings, and horses no longer engaged in horse racing (e.g., retired broodmares).

(2) A horse is presumed eligible for out-of-competition testing if:

- (a) It is on the grounds at a racetrack or training center under the jurisdiction of the Commission;
- (b) It is under the care or control of a trainer licensed by the Commission;
- (c) It is owned by an owner licensed by the Commission;
- (d) It is entered or nominated to race at a premises licensed by the Commission;
- (e) It has raced within the previous 12 months at a premises licensed by the Commission;
- (f) It is nominated to a program based on racing in the State.

(3) The presumptions set forth in this regulation are conclusive in the absence of evidence that a horse is not engaged in activities related to competing in horse racing in the State.

C. Selection of Horses to Be Tested.

(1) Horses shall be selected for sampling by a Commission veterinarian, the Executive Director, an equine medical director, a steward, a presiding judge, or a designee of any of the foregoing.

(2) Horses may be selected to be tested at random, for cause, or as otherwise determined in the discretion of the Commission.

(3) Licensees of the Commission shall cooperate and comply fully with the provisions of this regulation.

(4) Individuals who apply for and are granted a trainer or owner license shall be deemed to have given their consent for access at such premises as their horse may be found for the purpose of Commission representatives collecting out-of-competition samples. Licensees shall take any steps necessary to authorize access by Commission representatives at such premises.

D. Collection of Samples.

(1) Samples shall be taken under the supervision and direction of a person who is employed or designated by the Commission. All blood samples shall be collected by a veterinarian licensed in the State, or by a veterinary technician who is acting under appropriate supervision of the State-licensed veterinarian.

(2) Upon request of a representative of the Commission, the trainer, owner, or their specified designee shall provide the location of their horses eligible for out-of-competition testing.

(3) The Commission or its designees are not required to provide advance notice before arriving at any location, whether or not licensed by the Commission, to collect samples.

(4) The trainer, owner, or their specified designee shall fully cooperate with the person who takes samples for the Commission, including, but not limited to:

(a) Assisting in the immediate location and identification of the horse;

(b) Making the horse available as soon as practical upon arrival of the person who is responsible for collecting the samples;

(c) Providing a stall or other safe location to collect the samples;

(d) Assisting the person who is collecting samples in properly procuring the samples; and

(e) Witnessing the taking of samples including sealing of sample collection containers.

(5) The management and employees of a licensed racetrack or training facility at which a horse may be located shall cooperate fully with a person who is authorized to take samples. The person who collects samples for the Commission may require that the collection be done at a specified location on such premises.

(6) The Commission, if requested and in its sole discretion, may permit the trainer, owner, or their specified designee to present a horse that is located in the jurisdiction, but not at a racetrack or training center licensed by the Commission, to be sampled at a time and location designated by the Commission.

E. The Commission may arrange for the sampling of an out-of-State horse by the Commission or the Commission's designee if the horse is located in the State. The Commission or its designee shall follow the relevant provisions of this regulation.

F. The test results shall be made available to the Commission, subject to any restrictions on public disclosure of test results that may apply to the Commission.

G. The Commission, if requested and in its sole discretion, may permit the trainer or owner instead to transport the horse into the State for sampling at a time and place designated by the Commission.

H. The individual who takes samples for the Commission shall provide identification and disclose the purpose of the sampling to the trainer or designated attendant of the horse.

I. An owner or trainer does not consent to a search of the premises by making a horse that is not located at a racetrack or training center available for sampling.

J. If the trainer or other custodian of a selected horse refuses or declines to make the horse available for sampling and the managing owner has previously provided the Commission with a means for the Commission to give immediate notification to the managing owner in such situation, then the Commission shall attempt to notify the managing owner and the eligibility of the horse shall be preserved if the managing owner is able to make the horse available for immediate sampling. The Commission is not required to make repeated attempts to notify the managing owner.

K. The chain of custody record for the sample (including a split sample where appropriate) shall be maintained and made available to the trainer, owner, or their designee when a complaint results from an out-of-competition test.

L. The Commission may have out-of-competition samples tested to produce information that may enhance the ability of the Commission to enforce its medication and anti-doping rules.

M. An out-of-competition sample that is found to contain a prohibited substance may be adjudicated in the same manner as a post-race sample that is found to contain a prohibited substance.

N. Split sample rules and procedures for post-race testing shall apply to out-of-competition testing.

O. The Commission may use any remaining sample for research and investigation.

P. Willful failure to make a horse available for sampling or other willfully deceptive acts or interference in the sampling process shall constitute a violation of the Commission's laws and regulations and may be subject to penalties available under the applicable laws and regulations.

Q. A selected horse that is presumed eligible for out-of-competition testing shall be placed on the Steward's list and will be ineligible to race in the jurisdiction for 180 days if the horse is not sampled due to the trainer's, owner's or their designee's assertion that the horse is not engaged in activities related to competing in horse racing in the State. This restriction does not apply if the trainer, owner, or their designee voluntarily allows an immediate collection of the samples from the horse.



ATTENTION ALL HORSEMEN AND VETERINARIANS

New Mid-Atlantic Advisory regarding the use of Methylprednisolone Acetate (Depo-Medrol) and Procaine Penicillin

MRC RULES

This Advisory addresses concerns that have recently been expressed by horsemen and veterinarians regarding compliance with the uniform drug testing thresholds and guidelines for the use of Methylprednisolone Acetate (Depo-Medrol) and Procaine Penicillin. The regulators from the Mid-Atlantic racing states met on July 1, 2015 and announce the following Advisory.

METHYLPREDNISOLONE ACETATE (Depo-Medrol)

The testing threshold for methylprednisolone acetate (Depo-Medrol) is 100 pg/ml plasma. This testing threshold is based upon the administration of a total dose of 100 mg methylprednisolone as methylprednisolone acetate in one articular space. The recommended withdrawal time for this administration is a minimum of at least 21 days, but there is a footnote warning that intramuscular (IM) administrations can result in plasma concentrations that can exceed the testing threshold for weeks or months. It is important to understand that the testing threshold can be exceeded if there is: 1) an IM injection; 2) an injection in more than one articular space, 3) a different formulation (e.g., compounded) of methylprednisolone, and 4) an injection into a subcutaneous space, i.e. not injecting into the right spot. This is of particular concern when injecting stifles and hocks, as a portion of the medication often is inadvertently deposited into tissues outside the joint capsule. It is important to understand that when a portion of this drug is placed outside the joint capsule of any joint, an intramuscular or subcutaneous injection will be the result.

Accordingly, **it is recommended that 1) Depo-Medrol should not be administered to any horse a trainer wishes to race in the Mid-Atlantic region – New York, New Jersey, Pennsylvania, Delaware, Maryland, West Virginia and Virginia; and 2) a trainer who chooses to race a horse that has been treated with Depo-Medrol despite this warning should, at his/her expense, get**

the horse tested prior to entry to ensure that the horse will test below the testing threshold of 100 pg/ml plasma. The testing threshold of 100 pg/ml plasma will be enforced. PROCAINE PENICILLIN

The current Guideline for Procaine penicillin requires the reporting of the administration of this drug to the Racing Commission and a mandatory surveillance of the horse for 6 hours prior to the race if the trainer wishes to race the horse. The purpose of the quarantine is to ensure against a nerve block. The Guideline, however, does not specify how long after administration of procaine penicillin the reporting and mandatory surveillance requirements must be followed.




Effective immediately, only Procaine Penicillin administrations within 30 days of a race need be reported to the Racing Commission. The surveillance requirement remains in effect. The Racing Commission or the racetrack, as the case may be, will provide a security guard for the horse at the owner/trainer's expense. Please note that the testing threshold for Procaine Penicillin is 25 ng/ml plasma regardless of the surveillance requirement and this testing threshold will be enforced.
